We have a robust district team. We have worked with the Coquille Tribe to receive feedback on how this would impact their students and families specifically. We have surveyed all families in our district about re-opening and this includes EL, TAG, Sp.Ed., Economically Disadvantaged etc. Survey responses were used to revise the plan. The draft plan was shared on our website and Facebook. We again surveyed K-3 families about potential re-opening plans and considered those responses as plans were developed. The Board reviewed and solicited feedback on two occasions (the second time included provisions for Comprehensive Distance Learning to begin the year if metrics are not met for in-person reopening as well as K-3 exception opening) prior to approval on August 10, 2020.

### Describe why you are selecting Comprehensive Distance Learning as the school's Instructional Model for the effective dates of this plan.

Comprehensive Distance Learning is being selected due to the metrics that were released on July 28, 2020. In order for families to have a finite plan for the start of school and the district to have time to implement the full CDL Framework with fidelity, we felt like given the current status of the State's COVID cases planning to begin the year with CDL for at least the first 9-weeks was the best option for our district. This is a natural grading progress period and if metrics are met by then, this timeline will provide a great transition pivot point to our hybrid plan for students and staff.

At this point we have reviewed the CDL Guidance both as an administrative team as well as our district-wide planning team. At this time, we feel we can meet all requirements within this guidance and do not need ODE to review any requirements for possible accommodations. We would like the ability to bring students on site in very small groups who need intervention, SDI and additional supports but we are waiting for further guidance to come on this topic.

### Describe the school's plan, including the anticipated timeline, for returning to Hybrid Learning or On-Site Learning consistent with the *Ready Schools, Safe Learners* guidance.

Comprehensive Distance Learning is the District's plan beginning September 15, 2020 for at least the first 9-weeks of school or until the state and county metrics are being met for on-site and/or hybrid instruction.

Our plan includes 1:1 Chromebook roll out for students in grades 7-12. We will be utilizing Google Classroom. For the small number of students that have connectivity issues we will still deploy Chromebooks to them but we will be placing their lessons on flash drives, including lesson recordings, so they can get as much of the similar instruction as their counterparts. These students will also receive paper packets when needed. We will continue to work with our network and cellular carriers on connectivity issues and use our CDL Grant money to resolve issues as we are able.

We will begin the school year with CDL and we will begin Hybrid Learning once we have met both county and state level metrics for on-site in-person opening.

**Hybrid/Onsite Plan**

**Reporting to LPHA:** Logs of students and staff sent home with possible symptoms shall be sent to Coos Health and Wellness Public Health Department daily. Contract tracing shall be completed at their request.

**Isolation:** Isolations rooms are identified below. Rooms shall be staffed when occupied. All occupants in room will wear masks unless health conditions prohibit such use.

- **Myrtle Point Jr./Sr/ High:** Initially students will be sent to the library for isolation until they can be transported to the elementary school Health Room where they will be screened by Donna Johnson who is our licensed school nurse. They will then either be sent on to class or remain in isolation until they can be returned home depending on the screening outcome. The library isolation room at MPHS will be staffed by the library assistant.
- **Daily Logs- Contents and Maintenance:** Daily logs for student cohorts shall be created and stored for each student cohort (transportation, on-site hybrid cohort, and intervention cohort(s) for applicable students). Such logs shall be available at the main office of each building. Bus records from school-home trips shall be delivered with the home-school records each morning with the exception of Friday logs which shall be scanned and sent via email to the office manager at the conclusion of the Friday routes (We are working on digital scanners for the schools and busses-the bus logs would be uploaded automatically to the online storage device as well if this works out). These logs will be maintained in an online storage system through October 1<sup>st</sup> of 2021 at a minimum. These logs shall be shared directly with the Coos Health and Wellness Public Health Department and may be used as needed for contract tracing purposes.
